2022 ECA Dues - Pay Early and Help the Planet

In a few week, our annual letter will go out asking you to help support the ECA by paying voluntary dues of \$25 per household. Everyone who lives in the neighborhood is a member of the ECA, but only households that support the ECA receive a copy of the ECA Neighborhood Directory (updated annually and mailed in the late spring), along with access to the online Directory and phone app. In addition, only supporters are eligible to vote in ECA elections, which are held every other October.

However, if you make your dues payment <u>now</u>, you'll stop us from using the paper and other resources to print and deliver a letter. (Not to mention the cost and labor involved.)

Thank you to everyone who supported the ECA last year. Without you, our civic association could not exist. I hope you'll continue your support in 2022. If you're new to the neighborhood or, for whatever reason, did not pay dues last year, I hope you'll support the ECA this year.

The easiest way to pay dues is to visit the ECA website <u>HERE</u>. Click on the Pay Now button to pay by credit card, debit card, or PayPal. That will take you to a secure site to complete the transaction. You'll also find instructions on the website page if you'd rather pay by check or use Venmo. We strongly encourage you to use planet-friendly electronic means of payment.

Please take a few minutes now to make your dues payment. And, don't forget to keep a record of your payment so that when you receive another reminder, you'll know that you've already taken care of it.

Converting Parking Lots to Parks in Downtown Bethesda

A few days ago, I sent a letter to the Montgomery County Executive and the County Council supporting the recommendations of the Bethesda Downtown Plan Implementing Advisory Committee that the County fully fund a project to convert two Montgomery County parking lots near the Farm Women's Market (lots 10 and 24) into parks and move the parking underground. The conversion will be partially funded by the developers of the Farm Women's Market property and the Town of Chevy Chase, but additional county funding is needed for the project. Spring ECA Members' Meeting

Active Montgomery Event/Program Registration

Active Montgomery is the online portal where residents go to register for programs at Montgomery Parks and Montgomery County Recreation, or to reserve a County facility or a field. The County has updated its system to combine the databases for Montgomery County Recreation, Montgomery Parks, and Community Use of Public Facilities. They've also made the reservation process easier to use, with a more robust search tool and better security. Using the new Active Montgomery website, residents can:

- sign up for classes, events or other activities;
- reserve rooms in schools, libraries and other County facilities;
- reserve picnic areas and sports fields;
- obtain pool passes; and
- much more.

Remember that Spring Program Registration begins February 14 and Summer Camp Registration begins February 22. For more information, go <u>HERE</u>.

Dear County Executive Elrich and Members of the County Council:

I am the President of the Edgemoor Citizen's Association, a civic organization representing over 500 households in a neighborhood adjacent to downtown Bethesda. I'm writing to offer our wholehearted support for the conversion of Parking Lots 10 and 24 into public parks, as proposed in the Bernstein/EYA Farm Women's Market project. The addition of these public parks would be in keeping with the Bethesda Downtown Plan, has broad community support, and is also supported by the Bethesda Downtown Plan Implementation Advisory Committee.

The proposed parks and the replacement underground parking are to be financed, in part, by Bernstein/EYA and a voluntary contribution from the Town of Chevy Chase. However, County funds will be needed to fully fund the project. We urge you to help make this conversion happen by allocating the additional funds needed for this important project.

While these urgently needed new parks would benefit residents of nearby neighborhoods, they are also crucial to the success of downtown Bethesda. Along Wisconsin Avenue in the area closest to the proposed parks, nearly 2,500 new housing units have recently been built or are on their way along. Many thousands of square feet of office, hotel, and retail space have been added, with more coming. The proposed parks will provide critical public amenities for the many new residents, office workers, and shoppers, and will contribute to the success of the proposed retail space in the refurbished and expanded Farm Women's Market. Within walking distance of Bethesda Row, Metro, and the Purple Line, the parks will be a magnet for people not only from Bethesda but also from other areas of the County and beyond to meet, mingle, and relax. Please don't miss this opportunity to do something meaningful to meet Montgomery Parks vision of an "...enjoyable, accessible, safe, and green park system that promotes community through shared spaces and treasured experiences," during the period of massive development that is currently underway in downtown Bethesda.
