### 1. ECA Spring Social and Members Meeting

We had a great turnout for the Spring Social and Members meeting on May 3 at the Edgemoor Club. ECA members who attended heard a great presentation on the New MoCo Bicycle Master Plan and the draft Pedestrian Master Plan. We enjoyed excellent food and drink, good conversation, and a chance to meet some new neighbors.

Many thanks to ECA Board members Huda Montemarano and Alicia Tompkins for organizing and running the event, and to Kathleen Wheaton for her welcome assistance. In addition, thanks again to the Edgemoor Club, club manager Mary Gardiner, and club members for their generosity in allowing us to use their facilities.

If you were not able to make it to the event, I hope you can make it to the fall Social and Members Meeting. I'll send out information after we set the date, which is usually in October.

## 2. Planning Board Approves Draft of Pedestrian Master Plan

Speaking of the Pedestrian Master Plan - On May 25, the Montgomery County Planning Board approved the draft Plan, the county's first comprehensive master plan to improve the pedestrian experience countywide. The Planning Board transmit the draft to the County Council and the County Executive for public review and final County Council approval. There will be an opportunity for more public comment on the plan with the County Council's public hearing and work session review.

The Pedestrian Master Plan documents the pedestrian experience in Montgomery County today and makes recommendations in line with national and international best practices to improve that experience. The approval of the Planning Board Draft is the culmination of more than three years of Montgomery Planning research, analysis, data collection, expert collaboration, equitable community engagement and feedback, public hearings and presentations, as well as input and direction from Planning Board members during a series of live-streamed work sessions this spring.

## 3. ECA Dues Collection Report for 2023

This spring's annual ECA fund-raising effort resulted in 334 household supporting the ECA financially by each paying the voluntary annual dues of \$25. That's over 65% of the 512 households in the neighborhood – the largest number since I've been on the ECA board. We raised a total of \$8,350 for ECA projects, events, expenses, and activities. These include the <u>July 4<sup>th</sup></u> and <u>Halloween</u> Parades/Parties, the Members Socials/Meetings (see item #1, above), the New Year Brunch, new resident welcome baskets (see item # 6, below) and much more.

Every household that paid dues for 2023 will receive a copy of the 2023 ECA Neighborhood Directory, along with access to the online directory and mobile app. As Voting Members of the ECA, supporters are also eligible to vote in the upcoming ECA Board election this fall. If you didn't get around to sending in a dues payment this year, but still would like to support the ECA, just go to any page of the ECA website, click on the "Pay Dues" button in the upper right corner of the page, and then follow the simple instructions to make your contribution. We have a few extra copies of the new 2023 Neighborhood Directory. Until the supply runs out, we will provide a copy to households even if they missed the April 28 due date.

## 4. Bethesda Market Park Community Meeting (Zoom)

Montgomery Parks will hold an online community meeting to share preliminary plans for <u>Bethesda Market Park</u> - the new park under development that will be located adjacent to the historic Bethesda Farm Women's Market and the <u>Elm Street Urban</u> Park in downtown Bethesda. It will replace the two above-ground parking lots currently located there, which are being moved below ground.

This is the third public meeting about the Bethesda Market Park project. In March, Parks staff held two in-person meetings to gather input from community members about what amenities they would like to see in the park. The public was also encouraged to submit ideas through an online survey. Parks staff incorporated the ideas from the meetings and the survey in the proposed plan.

The meeting will be over Zoom on Wednesday, June 14, from 7:00-8:30 PM. Registration for the meeting is optional, but if you register <u>HERE</u>, you can sign up for future updates on the project

#### 5. New EC-Net Feature - Recommendations for Service Providers

One common way residents use EC-Net (the neighborhood email group) is to look for recommendations for a particular kind of service provider (e.g., doctor, plumber, painter, baby sitter). The group's posting rules prohibit sending responses to those kinds of messages to the entire group (only to the person who asked) – one of the many ways we keep the volume of unwanted messages to a minimum. However, some other users may find that kind of information helpful. ECA member Andrea Raab came up with a suggestion for how to make that information available to anyone who wants it, but without sending it out to another 600 or so people in the email group who don't.

If you want to recommend a service provider to neighbors, or you are looking for a service provider, please check out the <u>ECA's Compilation of Service Provider</u> <u>Recommendations</u>. This Google Spreadsheet contains provider recommendations compiled by neighbors, for neighbors, arranged by type of service. If you want to recommend someone, please feel free to add them to the spreadsheet, which is open to everyone. If you're looking for someone, check the spreadsheet before posting a request in EC-Net. If you receive recommendations from other neighbors, please feel free to add them to the document so they'll be available to everyone. The current version of the spreadsheet has only a few recommendations in it, but the number will grow as you and others add recommendations.

#### 6. Welcoming New Neighbors - Update

A little more than 2 years ago, the ECA started a new project to foster community by welcoming new residents to the neighborhood. ECA Vice President Huda Montemarano (along with former Board member Susan Hendrickson) developed the project, and has been delivering welcome baskets to new neighbors containing gift cards from local merchants along with other gifts and information about the area. We've tried to find and contact all new residents who move into the neighborhood and, although we missed a few, we think we found most of them.

Last week, Huda delivered our 50<sup>th</sup> (!!) welcome basket to a new family on Moorland Lane. Thank you, Huda.

#### 7. Recycling Achievement Awards
